



The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH Großbeeren are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH Großbeeren compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Wohnungsbaugesellschaft mbH Großbeeren is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.510% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 294% points below the market average of 361%.
