



## Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH Rank 23 of 396



The relative strengths and weaknesses of Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 216% points. The greatest weakness of Katholisches Wohnungsbau und Siedlungswerk der Diözese Regensburg GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.523% points.

The company's Economic Capital Ratio, given in the ranking table, is 216%, being 145% points below the market average of 361%.
