



The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH der Hansestadt Wismar are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH der Hansestadt Wismar compared to the market average is the variable Is Netincome Regular Operatingtc Depramort Remainder, increasing the Economic Capital Ratio by 2.446% points. The greatest weakness of Wohnungsbaugesellschaft mbH der Hansestadt Wismar is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 23.436% points.

The company's Economic Capital Ratio, given in the ranking table, is 2.446%, being 2.084% points above the market average of 361%.
