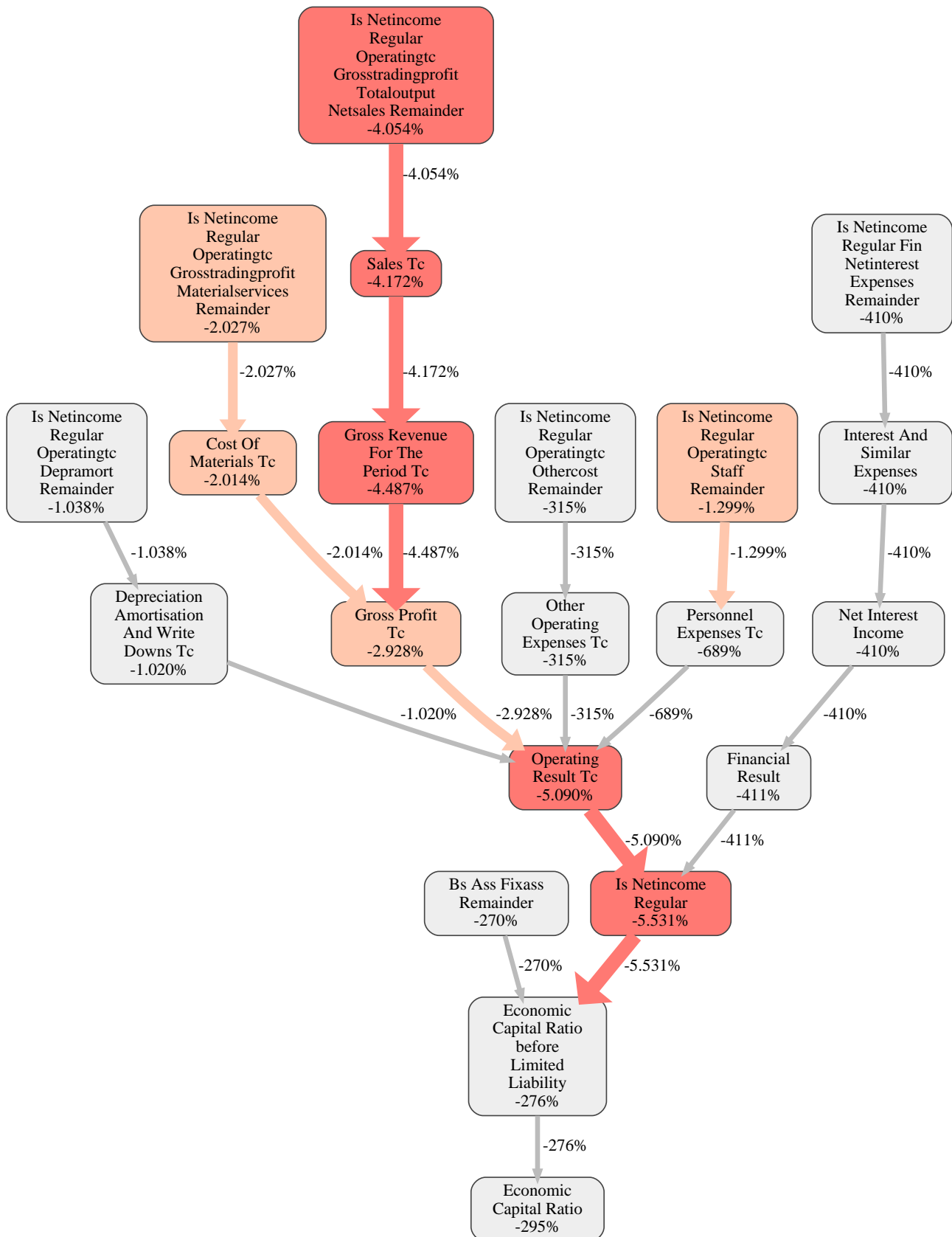

The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH der Stadt Barth are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH der Stadt Barth compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Wohnungsbaugesellschaft mbH der Stadt Barth is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.531% points.

The company's Economic Capital Ratio, given in the ranking table, is 66%, being 295% points below the market average of 361%.
