



The relative strengths and weaknesses of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 155% points. The greatest weakness of SWD Städt Wohnungsbau GmbH Co KG Düsseldorf is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.553% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 207% points below the market average of 361%.
