The greatest strength of wb Service GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 0,0015% points. The greatest weakness of wb Service GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 4.701% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,0015%, being 361% points below the market average of 361%.
