



The relative strengths and weaknesses of Wassmann und Söhne GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wassmann und Söhne GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 212% points. The greatest weakness of Wassmann und Söhne GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.492% points.

The company's Economic Capital Ratio, given in the ranking table, is 212%, being 149% points below the market average of 361%.
