

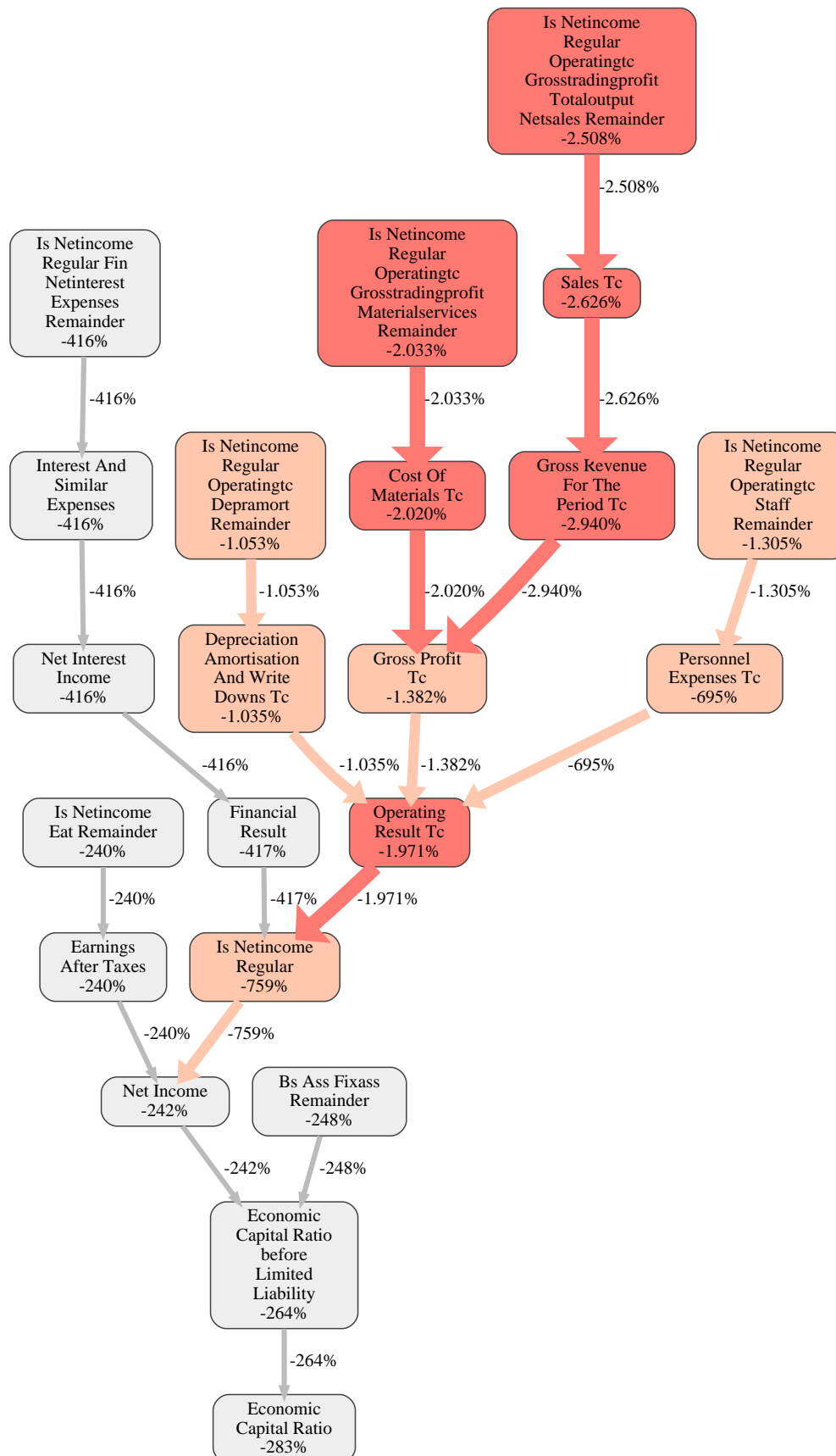

The relative strengths and weaknesses of Fuchs Bau Gesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fuchs Bau Gesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Fuchs Bau Gesellschaft mbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 2.940% points.

The company's Economic Capital Ratio, given in the ranking table, is 78%, being 283% points below the market average of 361%.
