

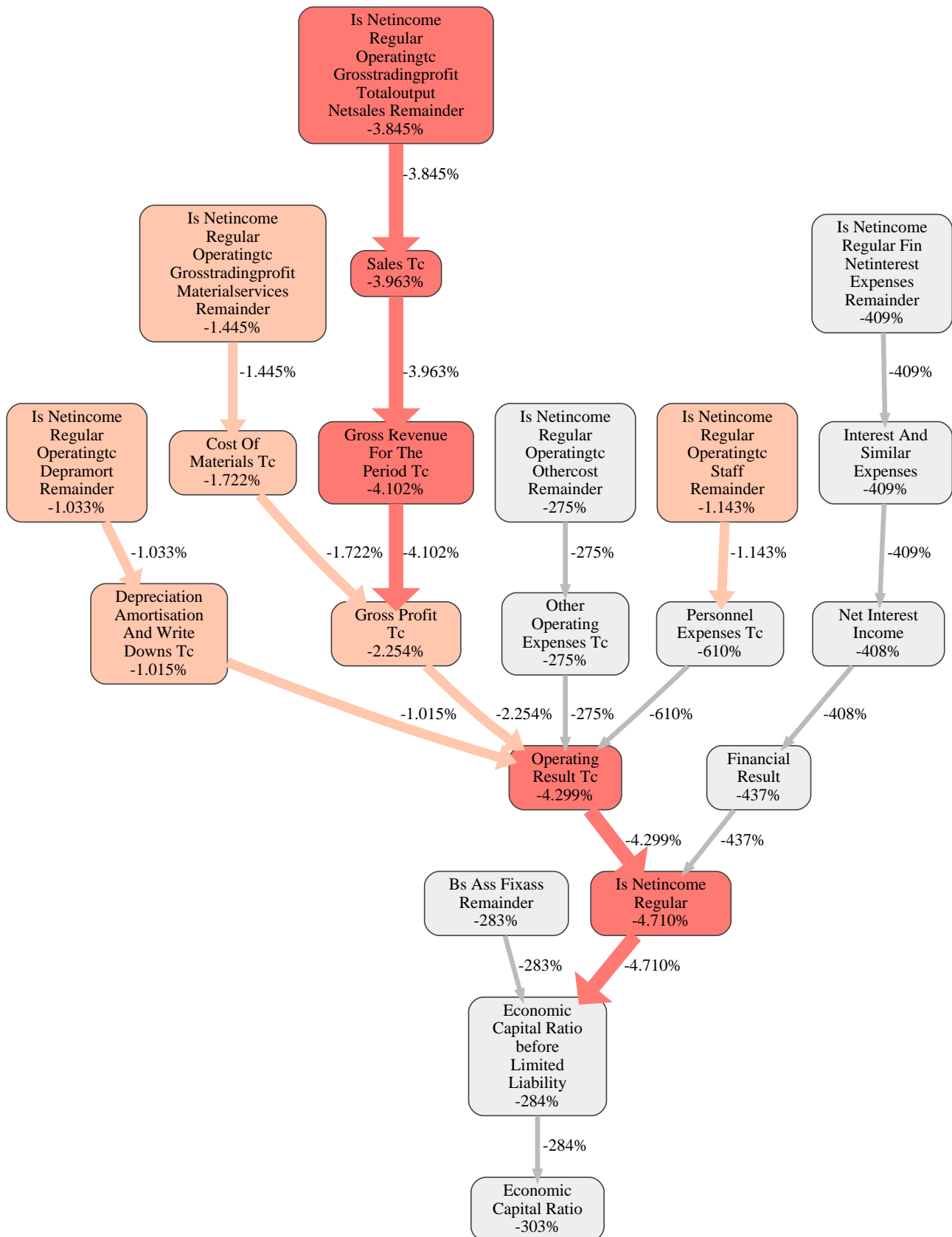

The relative strengths and weaknesses of Implenla Civil Engineering GmbH Vormals Implenla Construction GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenla Civil Engineering GmbH Vormals Implenla Construction GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Implenla Civil Engineering GmbH Vormals Implenla Construction GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 4.710% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 303% points below the market average of 361%.
