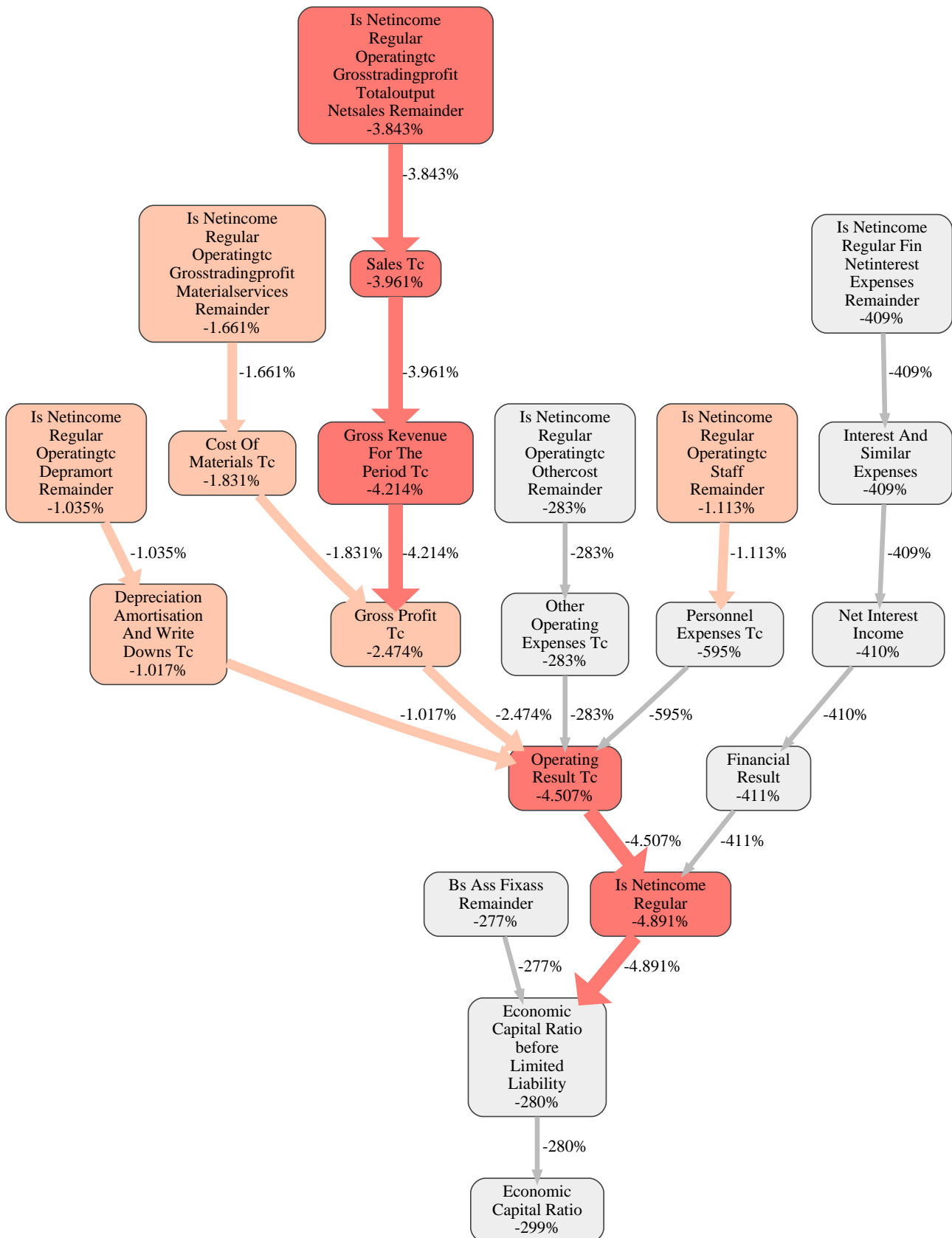

The relative strengths and weaknesses of Eiffage Infra Bau SE Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Eiffage Infra Bau SE Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Eiffage Infra Bau SE Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 4.891% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 299% points below the market average of 361%.
