



The relative strengths and weaknesses of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 39% points. The greatest weakness of Gewobag Wohnungsbau Aktiengesellschaft Berlin Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.504% points.

The company's Economic Capital Ratio, given in the ranking table, is 39%, being 322% points below the market average of 361%.
