The greatest strength of GWG Städtische Wohnungsgesellschaft München mbH Konzern compared to the market average is the variable Is Netincome Regular Fin Netinterest Expenses Remainder, increasing the Economic Capital Ratio by 95.684% points. The greatest weakness of GWG Städtische Wohnungsgesellschaft München mbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 2.010.755% points.

The company's Economic Capital Ratio, given in the ranking table, is 95.684%, being 95.323% points above the market average of 361%.
