The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 4.778% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 277% points below the market average of 361%.
