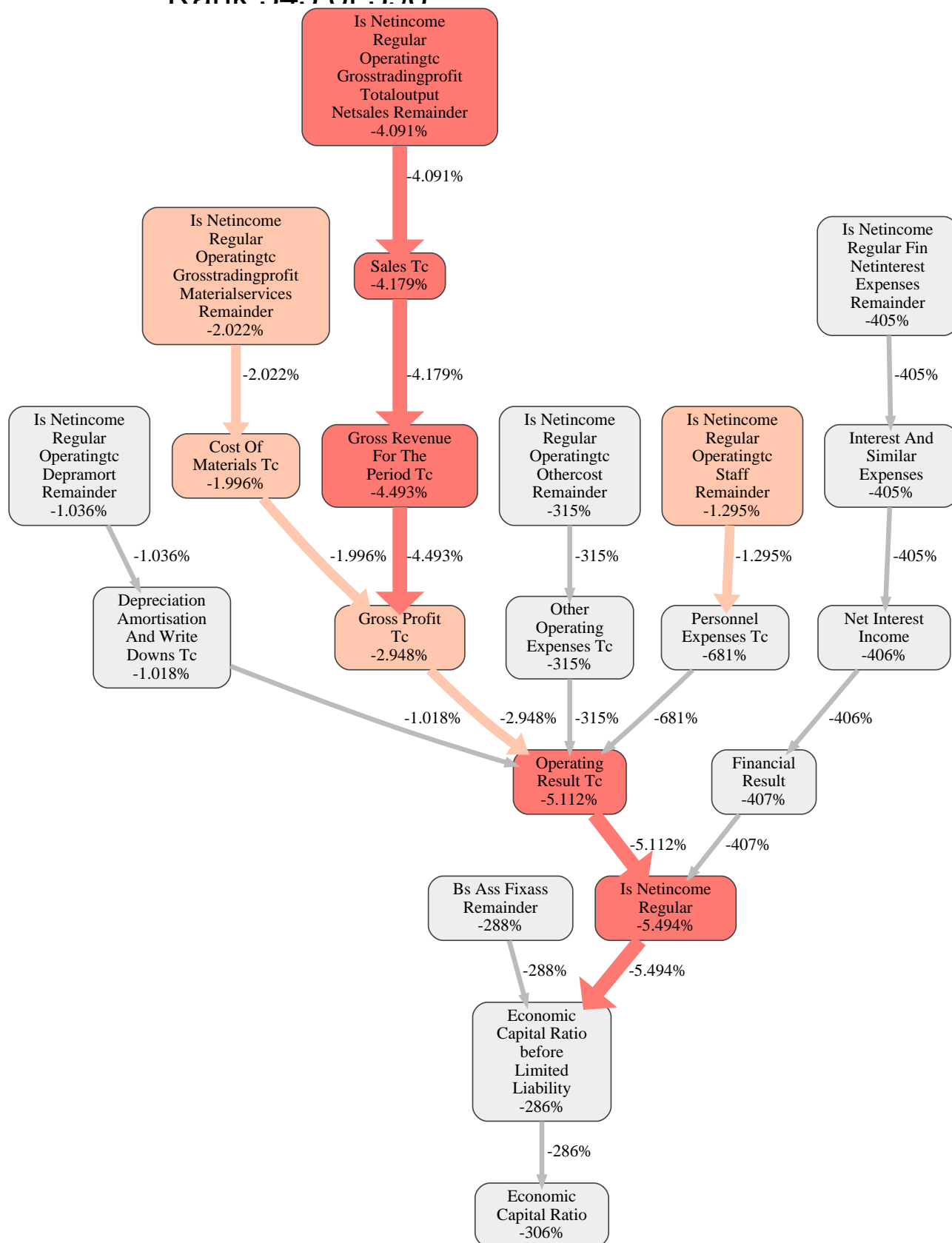

The relative strengths and weaknesses of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 56% points. The greatest weakness of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.494% points.

The company's Economic Capital Ratio, given in the ranking table, is 56%, being 306% points below the market average of 361%.
