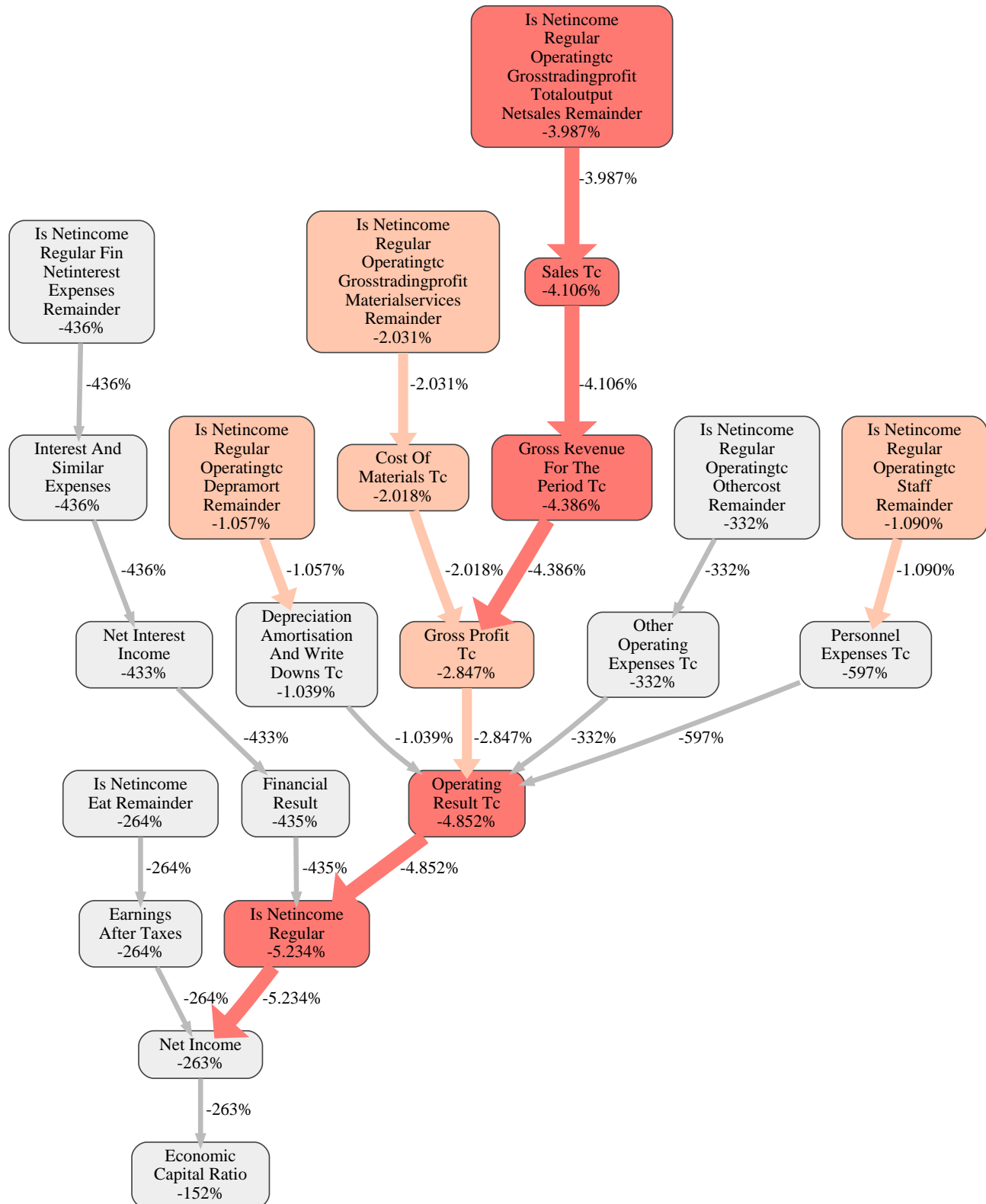

We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lebenshilfe Bayern Mitte GmbH Vormals Lebenshilfe Werkstätten der Region 10 Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 209% points. The greatest weakness of Lebenshilfe Bayern Mitte GmbH Vormals Lebenshilfe Werkstätten der Region 10 Gesellschaft mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.234% points.

The company's Economic Capital Ratio, given in the ranking table, is 209%, being 152% points below the market average of 361%.

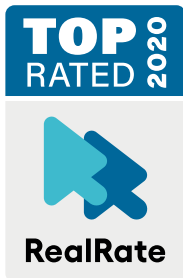
