

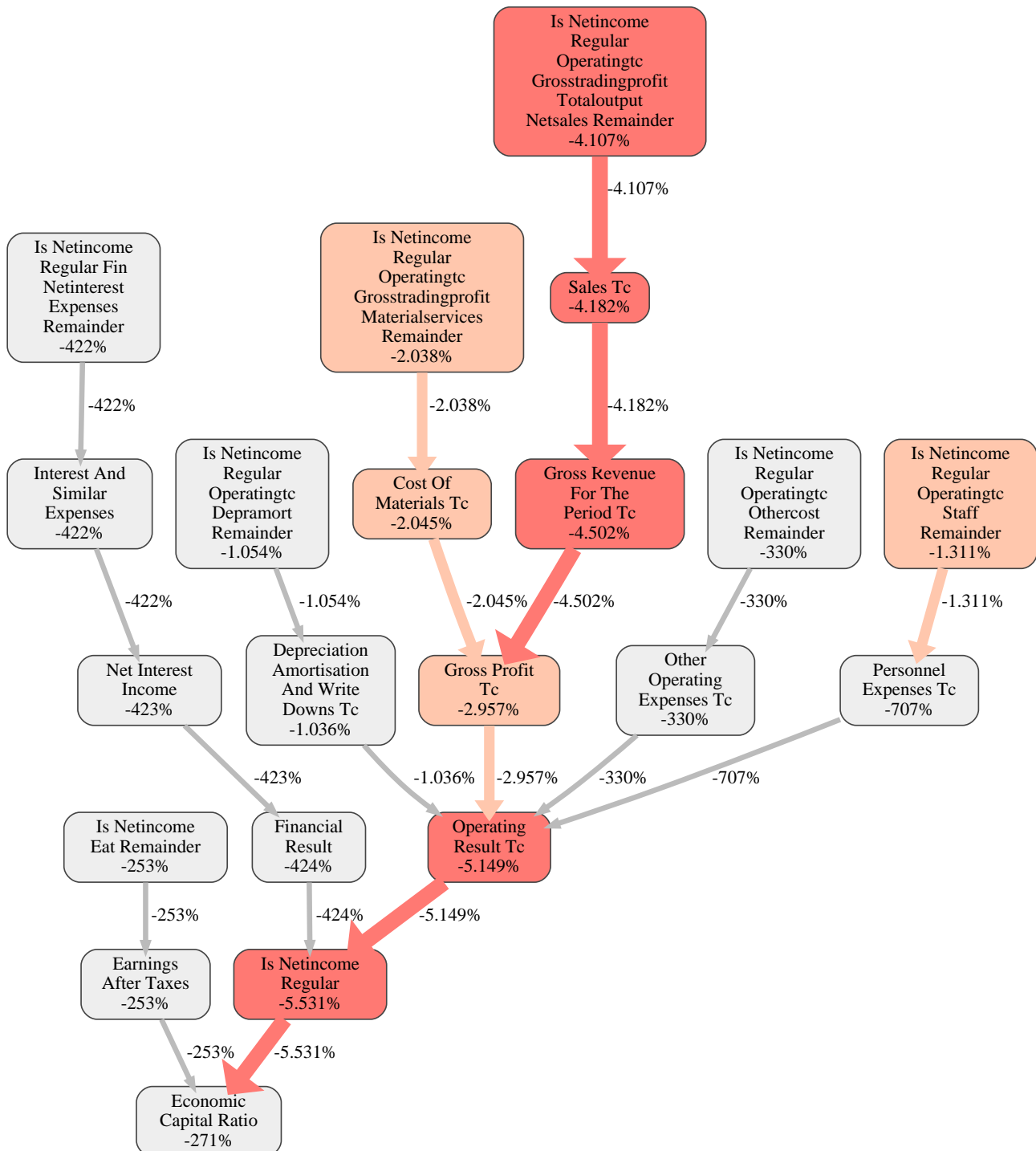

The relative strengths and weaknesses of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.531% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 271% points below the market average of 361%.
