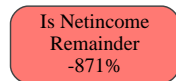

The greatest strength of Florack Bauunternehmung GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Florack Bauunternehmung GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 871% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 11% points below the market average of 103%.
