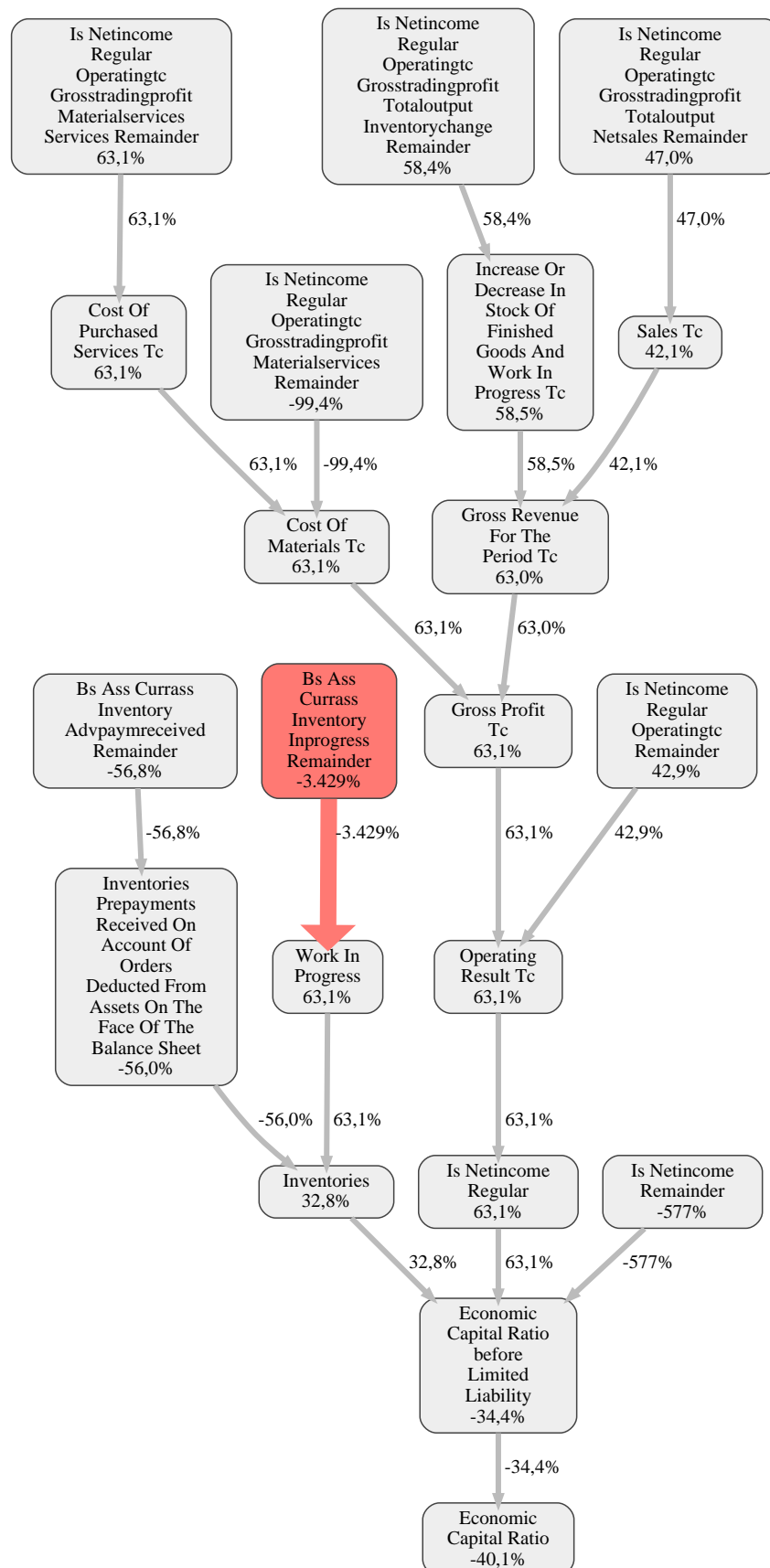

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 63% points. The greatest weakness of BMS Industriebau GmbH is the variable Bs Ass Currass Inventory Inprogress Remainder, reducing the Economic Capital Ratio by 3.429% points.

The company's Economic Capital Ratio, given in the ranking table, is 63%, being 40% points below the market average of 103%.
