



The relative strengths and weaknesses of W Markgraf GmbH Co KG Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of W Markgraf GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of W Markgraf GmbH Co KG Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 627% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 13% points below the market average of 103%.
