





The relative strengths and weaknesses of Mayerhofer Hoch Tief und Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mayerhofer Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, increasing the Economic Capital Ratio by 131% points. The greatest weakness of Mayerhofer Hoch Tief und Ingenieurbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 339% points.

The company's Economic Capital Ratio, given in the ranking table, is 131%, being 28% points above the market average of 103%.
