



The relative strengths and weaknesses of Unglehrt GmbH Co KG Bauunternehmen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Unglehrt GmbH Co KG Bauunternehmen compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 179% points. The greatest weakness of Unglehrt GmbH Co KG Bauunternehmen is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 529% points.

The company's Economic Capital Ratio, given in the ranking table, is 180%, being 77% points above the market average of 103%.
