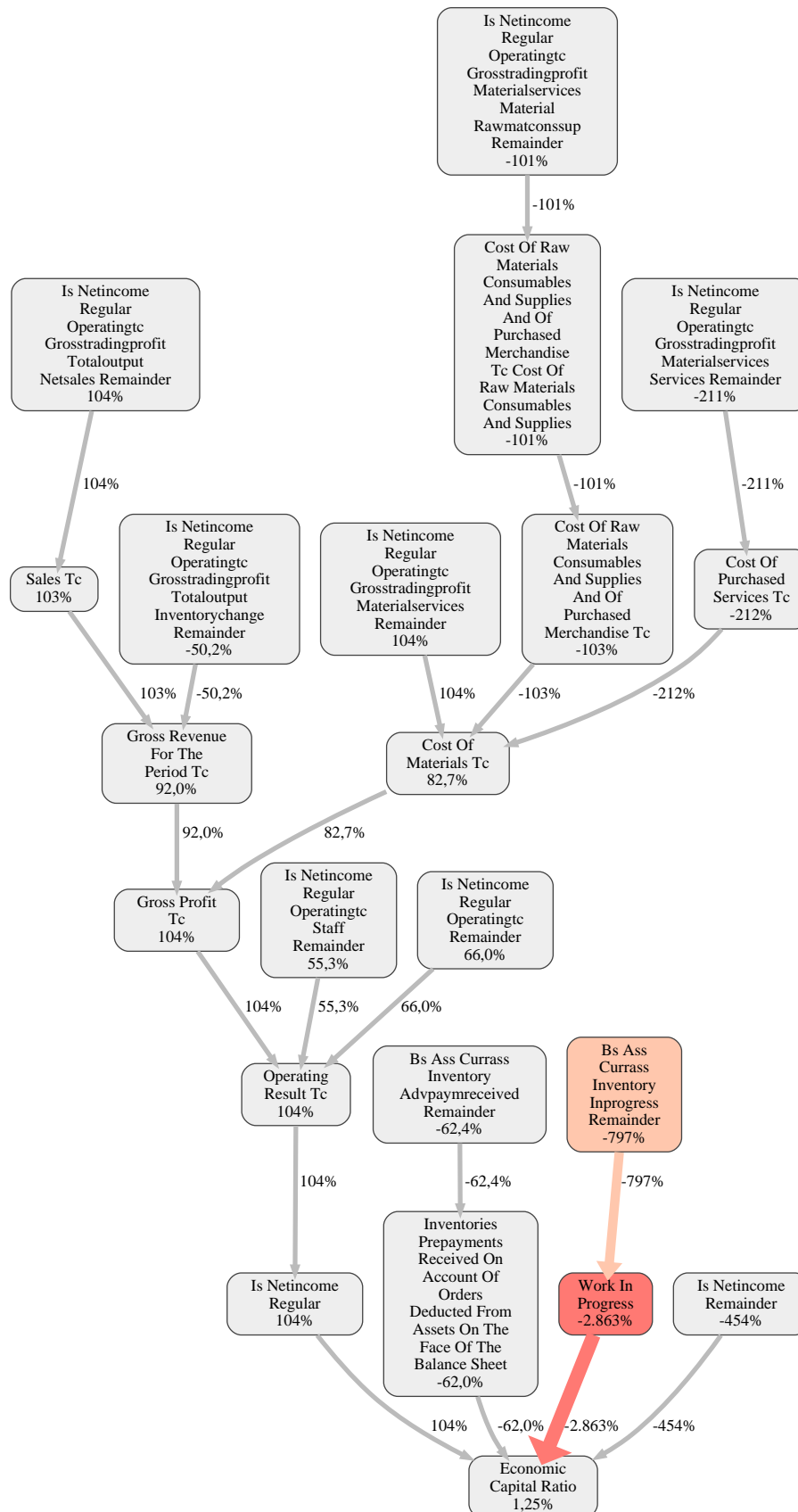

The greatest strength of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 104% points. The greatest weakness of Dipl Ing Emil Hönninger GmbH Co Bauunternehmung KG is the variable Work In Progress, reducing the Economic Capital Ratio by 2.863% points.

The company's Economic Capital Ratio, given in the ranking table, is 104%, being 1,3% points above the market average of 103%.
