The greatest strength of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Remainder, increasing the Economic Capital Ratio by 221% points. The greatest weakness of Josef Randlshofer Sohn Hoch und Tiefbauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 640% points.

The company's Economic Capital Ratio, given in the ranking table, is 222%, being 119% points above the market average of 103%.
