



The relative strengths and weaknesses of Josef Pfaffinger Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Pfaffinger Bauunternehmung GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 155% points. The greatest weakness of Josef Pfaffinger Bauunternehmung GmbH is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 986% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 52% points above the market average of 103%.
