The greatest strength of Josef Rädlinger Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Josef Rädlinger Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 237% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 20% points below the market average of 103%.
