



The relative strengths and weaknesses of Bauunternehmung Glöckle Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle Hoch und Tiefbau GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 111% points. The greatest weakness of Bauunternehmung Glöckle Hoch und Tiefbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 928% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 8,1% points above the market average of 103%.
