

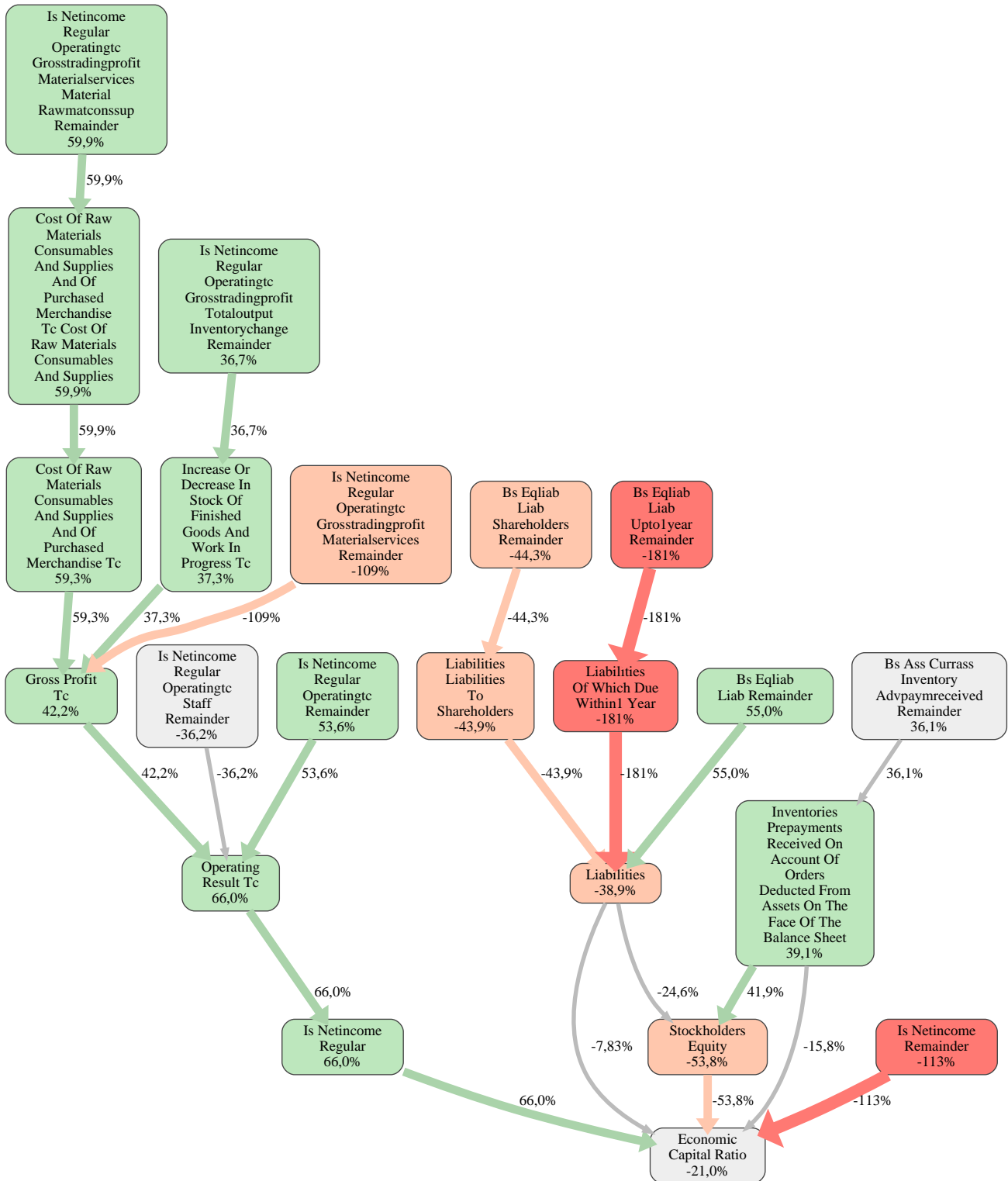

The relative strengths and weaknesses of Kruppa Bauunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kruppa Bauunternehmen GmbH Co KG compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 66% points. The greatest weakness of Kruppa Bauunternehmen GmbH Co KG is the variable Bs Eqliab Liab Upto1year Remainder, reducing the Economic Capital Ratio by 181% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 21% points below the market average of 103%.
