

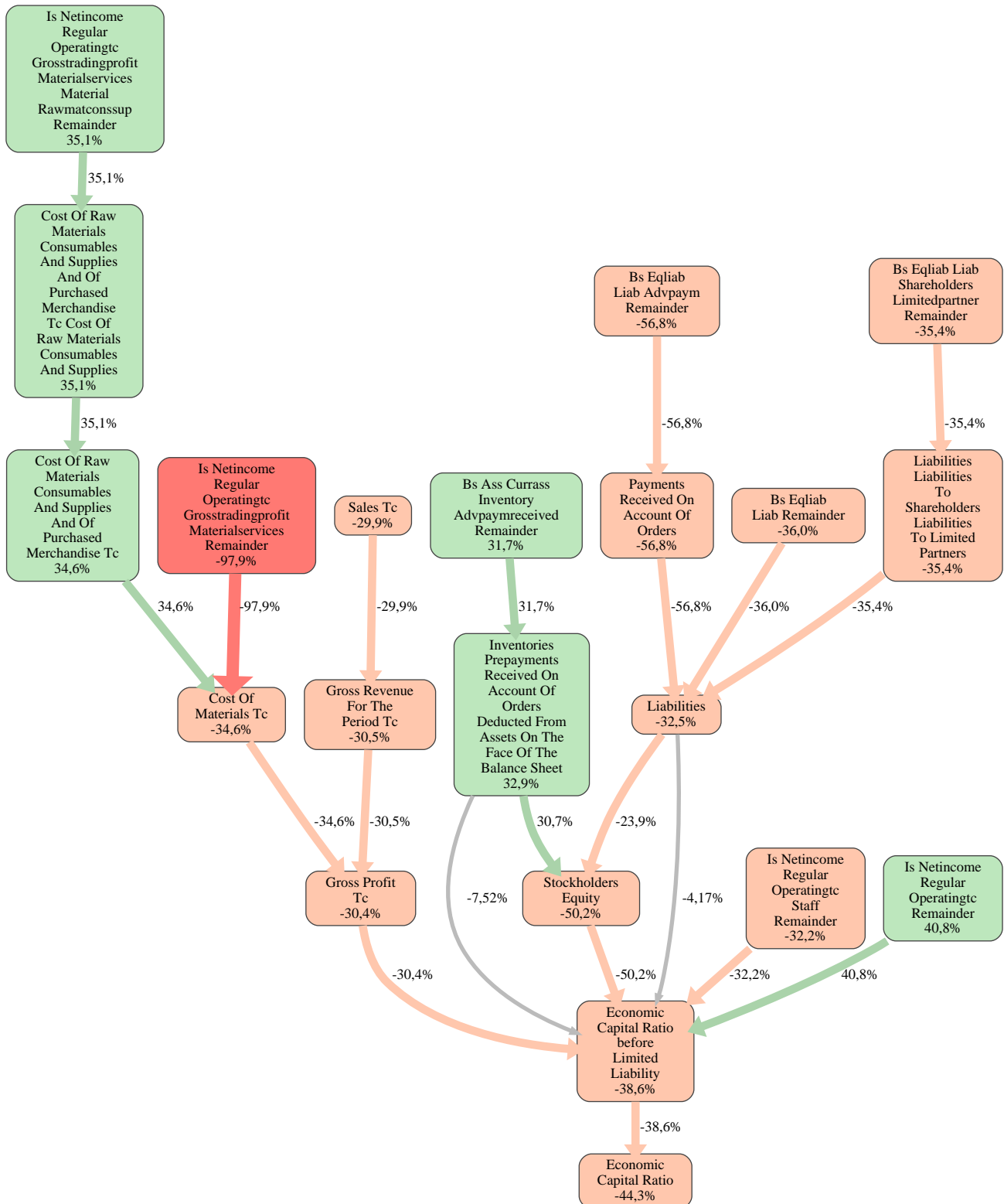

The relative strengths and weaknesses of Josef Fuchs Bauunternehmen GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Josef Fuchs Bauunternehmen GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Remainder, increasing the Economic Capital Ratio by 41% points. The greatest weakness of Josef Fuchs Bauunternehmen GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 98% points.

The company's Economic Capital Ratio, given in the ranking table, is 59%, being 44% points below the market average of 103%.
