The greatest strength of Gottfried Stehnke Bauunternehmung GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 266% points. The greatest weakness of Gottfried Stehnke Bauunternehmung GmbH Co KG is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 1.041% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 163% points above the market average of 103%.
