



The relative strengths and weaknesses of Angermüller Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Angermüller Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 202% points. The greatest weakness of Angermüller Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 322% points.

The company's Economic Capital Ratio, given in the ranking table, is 202%, being 99% points above the market average of 103%.
