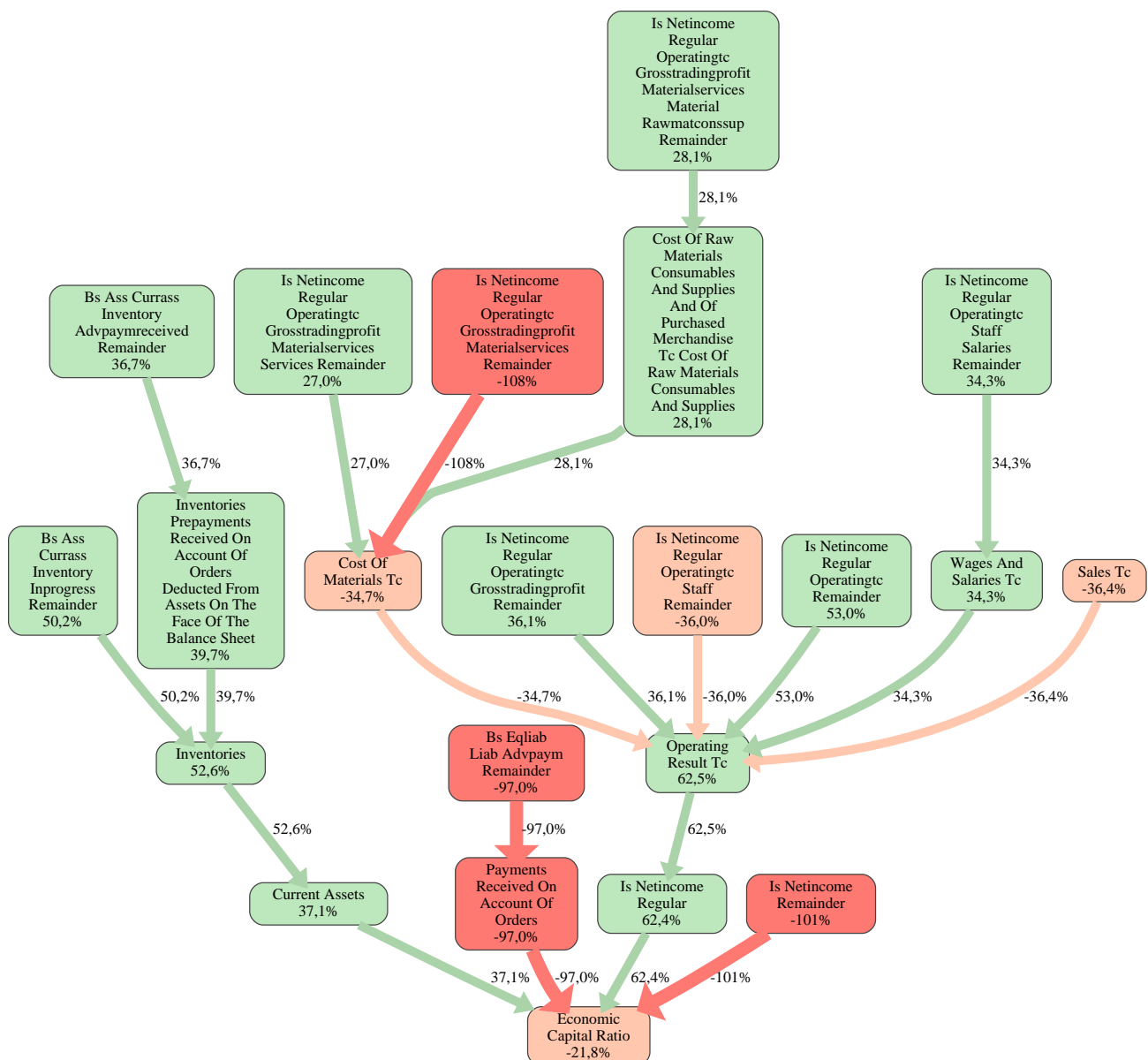

The relative strengths and weaknesses of Lim Hoch und Tiefbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lim Hoch und Tiefbau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 63% points. The greatest weakness of Lim Hoch und Tiefbau GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, reducing the Economic Capital Ratio by 108% points.

The company's Economic Capital Ratio, given in the ranking table, is 81%, being 22% points below the market average of 103%.
