



The relative strengths and weaknesses of Bauhof West Service GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauhof West Service GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 148% points. The greatest weakness of Bauhof West Service GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.526% points.

The company's Economic Capital Ratio, given in the ranking table, is 148%, being 45% points above the market average of 103%.
