

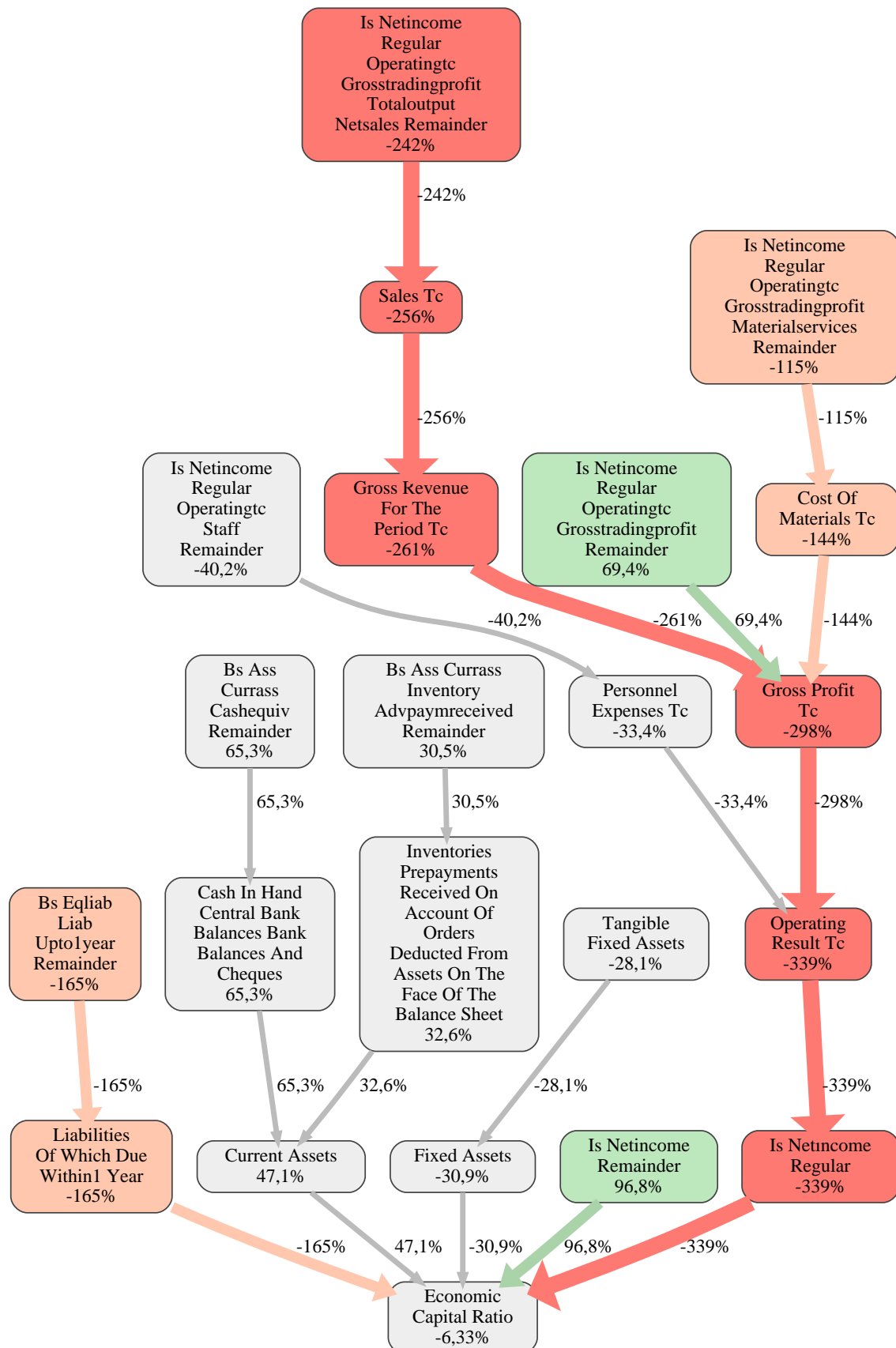

The relative strengths and weaknesses of SF BAU Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of SF BAU Moser GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 97% points. The greatest weakness of SF BAU Moser GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 339% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 6,3% points below the market average of 103%.
