



The relative strengths and weaknesses of Giebel Hoch und Tiefbau AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Giebel Hoch und Tiefbau AG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 209% points. The greatest weakness of Giebel Hoch und Tiefbau AG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 306% points.

The company's Economic Capital Ratio, given in the ranking table, is 220%, being 117% points above the market average of 103%.
