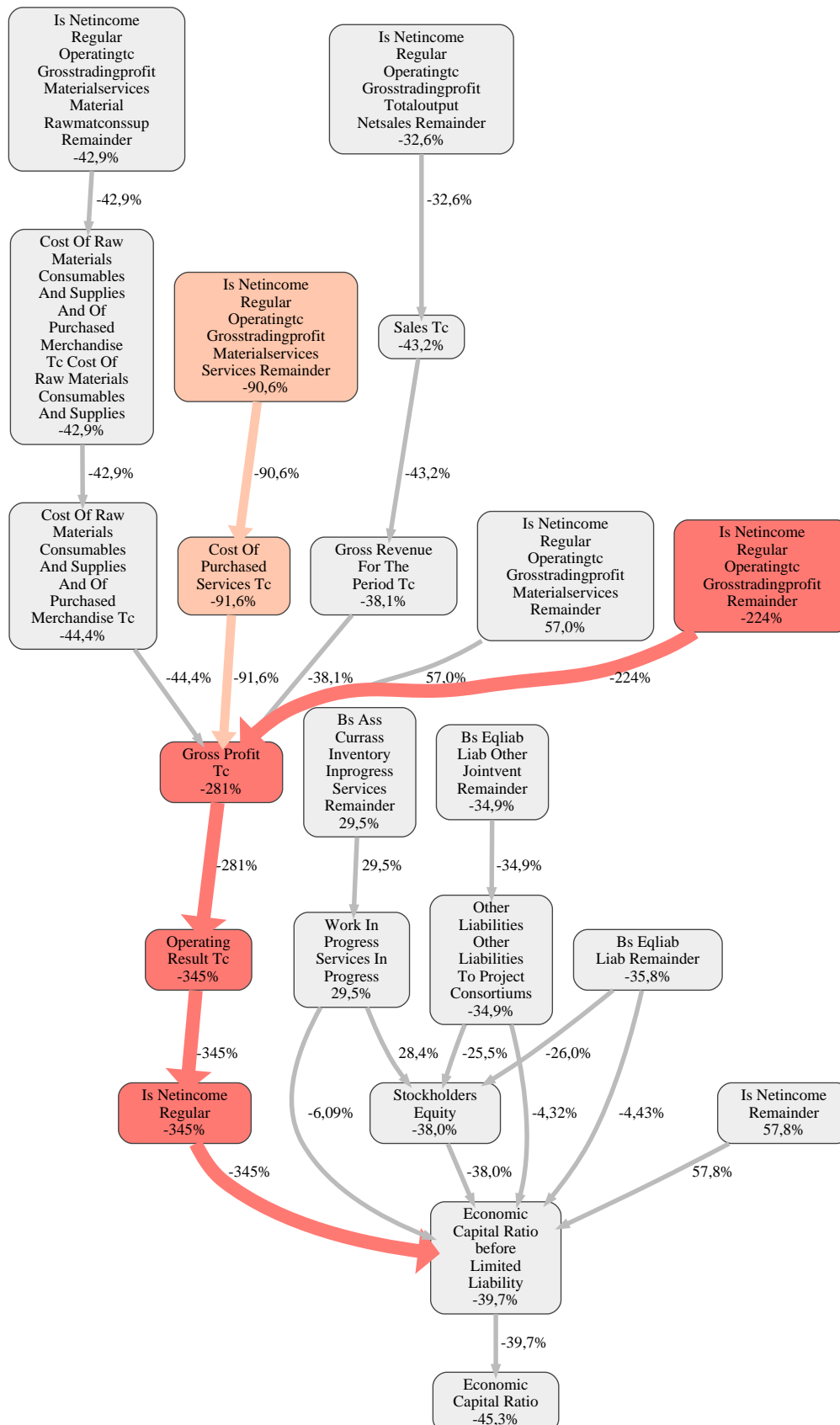

The greatest strength of Mauss Bau GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Mauss Bau GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 345% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 45% points below the market average of 103%.
