



The relative strengths and weaknesses of Bremer Hamburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer Hamburg GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 218% points. The greatest weakness of Bremer Hamburg GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 754% points.

The company's Economic Capital Ratio, given in the ranking table, is 218%, being 115% points above the market average of 103%.
