The relative strengths and weaknesses of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of BGW Bielefelder Gesellschaft für Wohnen und Immobiliendienstleistungen mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 325% points.

The company's Economic Capital Ratio, given in the ranking table, is 61%, being 42% points below the market average of 103%.
