The greatest strength of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Wohnungsbaugesellschaft mit Beschränkter Haftung Salzgitter is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 340% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 12% points below the market average of 103%.
