



The relative strengths and weaknesses of Wohnungsbaugesellschaft Kreis Steinfurt mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Kreis Steinfurt mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Wohnungsbaugesellschaft Kreis Steinfurt mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 330% points.

The company's Economic Capital Ratio, given in the ranking table, is 90%, being 14% points below the market average of 103%.
