The greatest strength of Münchner Wohnen Immobilien 4 GmbH Vormals GWG Städtische Wohnungsgesellschaft München mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Münchner Wohnen Immobilien 4 GmbH Vormals GWG Städtische Wohnungsgesellschaft München mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 345% points.

The company's Economic Capital Ratio, given in the ranking table, is 84%, being 20% points below the market average of 103%.
