



The relative strengths and weaknesses of Wusterhausener Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wusterhausener Wohnungsbaugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Wusterhausener Wohnungsbaugesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 347% points.

The company's Economic Capital Ratio, given in the ranking table, is 140%, being 37% points above the market average of 103%.
