

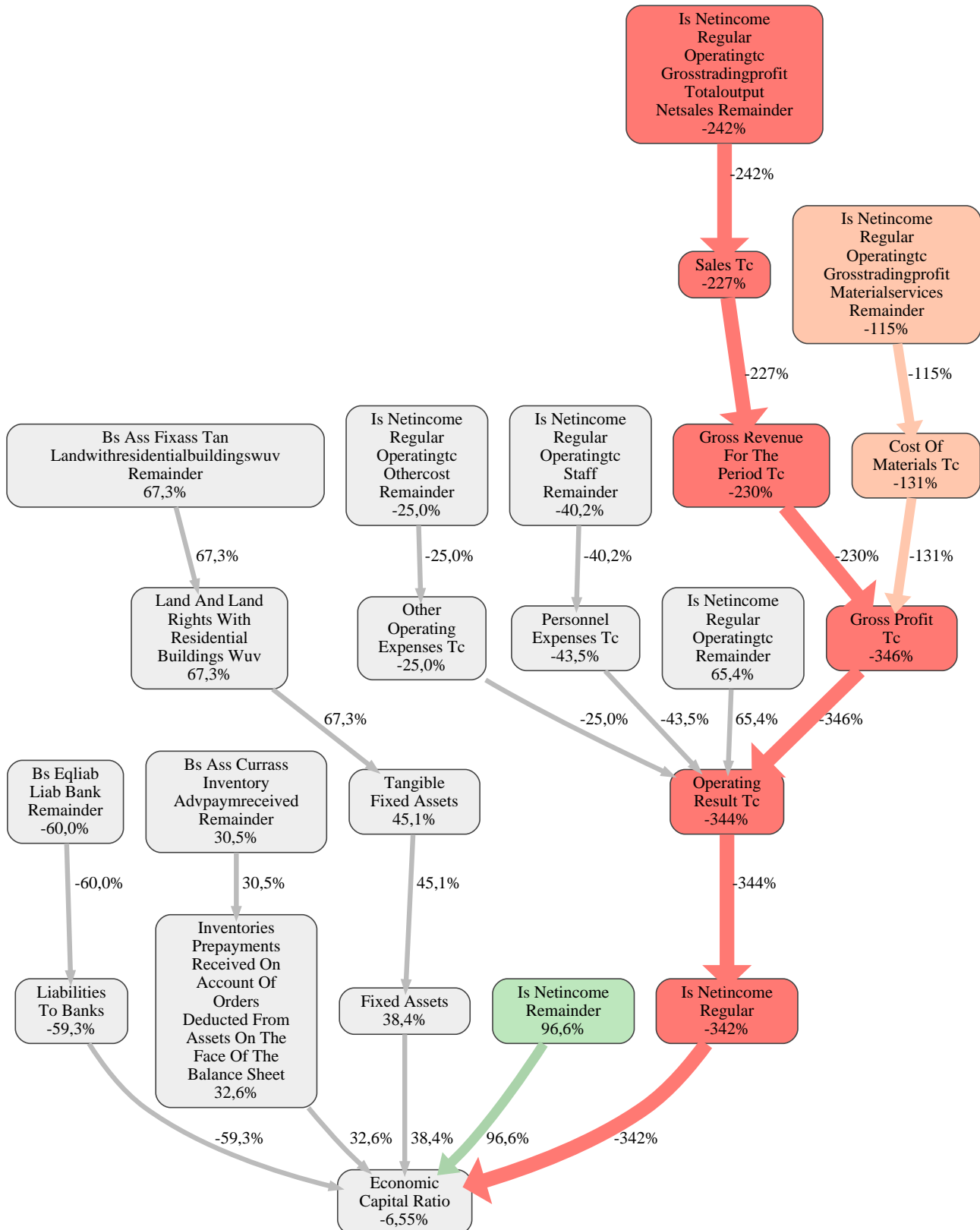

The relative strengths and weaknesses of WGT Wohnungsbaugesellschaft Teltow mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WGT Wohnungsbaugesellschaft Teltow mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 97% points. The greatest weakness of WGT Wohnungsbaugesellschaft Teltow mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 346% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 6,6% points below the market average of 103%.
