

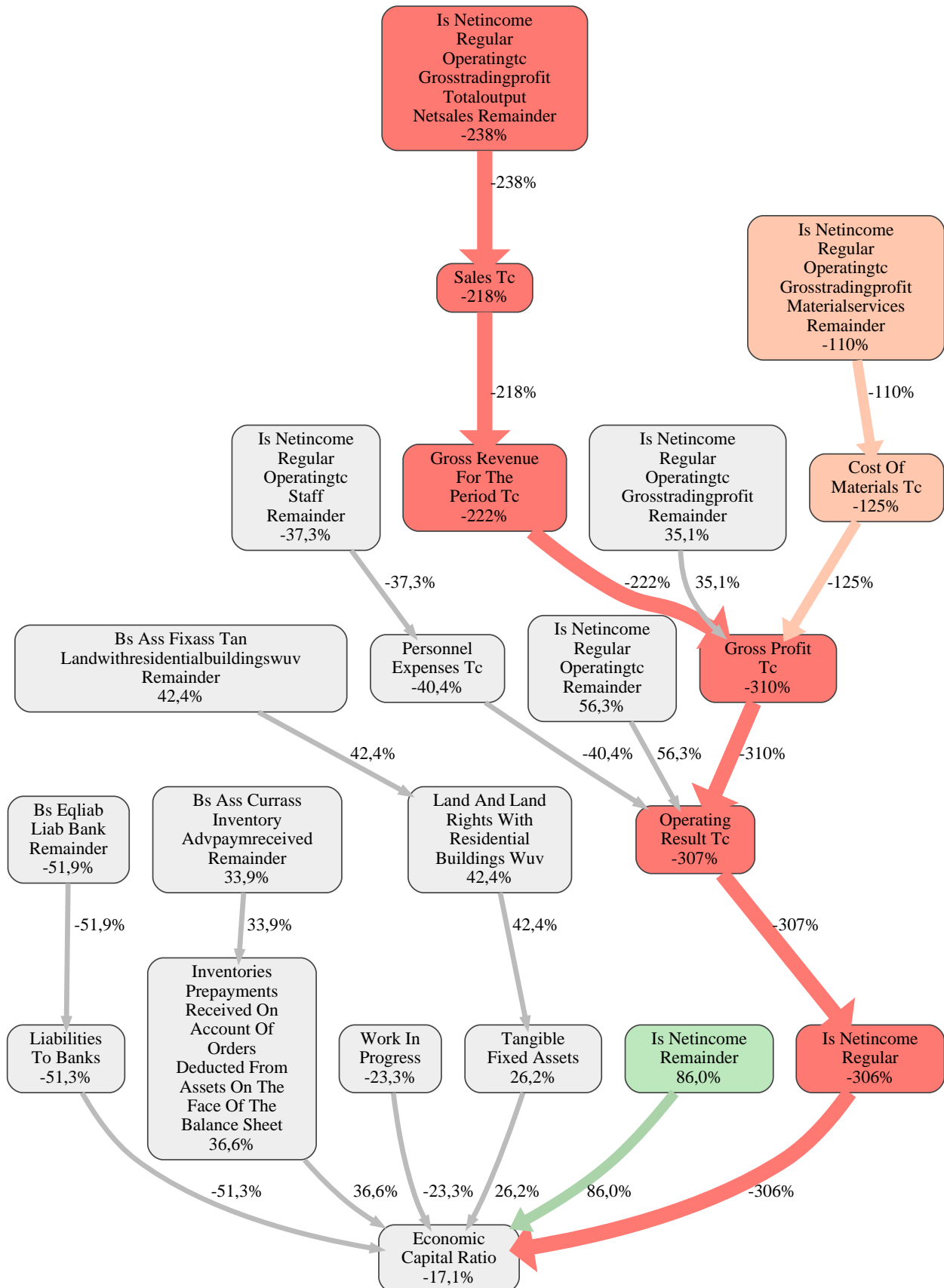

The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Ketzin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Ketzin compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Ketzin is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 310% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 17% points below the market average of 103%.
