The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mit Beschränkter Haftung Dahme Mark are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mit Beschränkter Haftung Dahme Mark compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 55% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mit Beschränkter Haftung Dahme Mark is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 291% points.

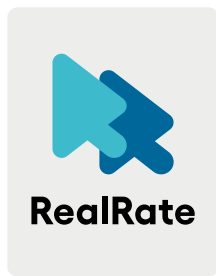
The company's Economic Capital Ratio, given in the ranking table, is 55%, being 48% points below the market average of 103%.
