

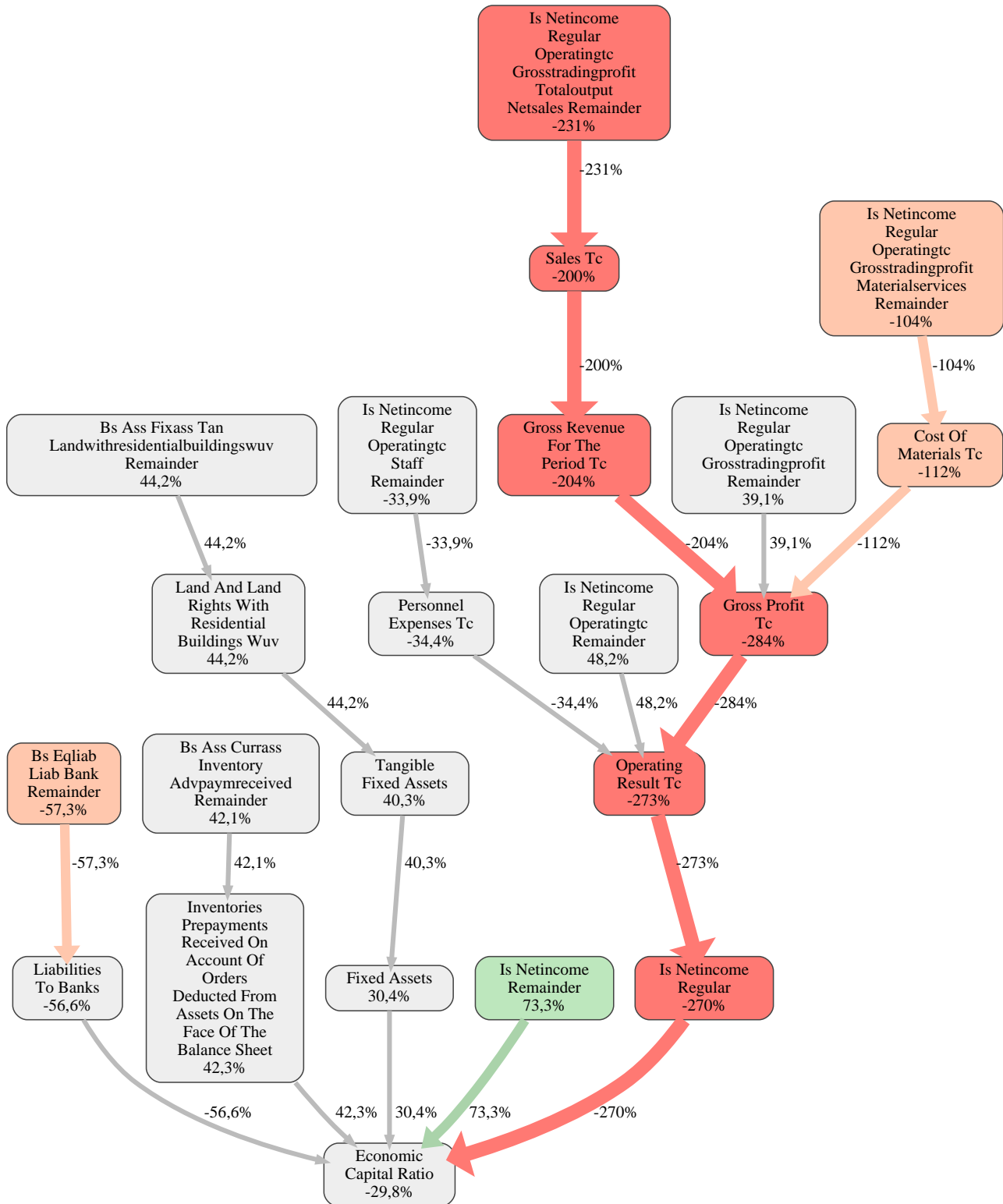

The relative strengths and weaknesses of WWV Wittenburger Wohnungsbau und Verwaltungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WWV Wittenburger Wohnungsbau und Verwaltungsgesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 73% points. The greatest weakness of WWV Wittenburger Wohnungsbau und Verwaltungsgesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 284% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 30% points below the market average of 103%.
