



The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH der Hansestadt Wismar are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH der Hansestadt Wismar compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 79% points. The greatest weakness of Wohnungsbaugesellschaft mbH der Hansestadt Wismar is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 306% points.

The company's Economic Capital Ratio, given in the ranking table, is 79%, being 24% points below the market average of 103%.
