



The relative strengths and weaknesses of Wohnungsbaugesellschaft der Lutherstadt Eisleben mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft der Lutherstadt Eisleben mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 102% points. The greatest weakness of Wohnungsbaugesellschaft der Lutherstadt Eisleben mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 301% points.

The company's Economic Capital Ratio, given in the ranking table, is 102%, being 1,1% points below the market average of 103%.
