



The relative strengths and weaknesses of WiWO Servicegesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of WiWO Servicegesellschaft mbH compared to the market average is the variable Personnel Expenses Tc, increasing the Economic Capital Ratio by 54% points. The greatest weakness of WiWO Servicegesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 344% points.

The company's Economic Capital Ratio, given in the ranking table, is 54%, being 49% points below the market average of 103%.
