

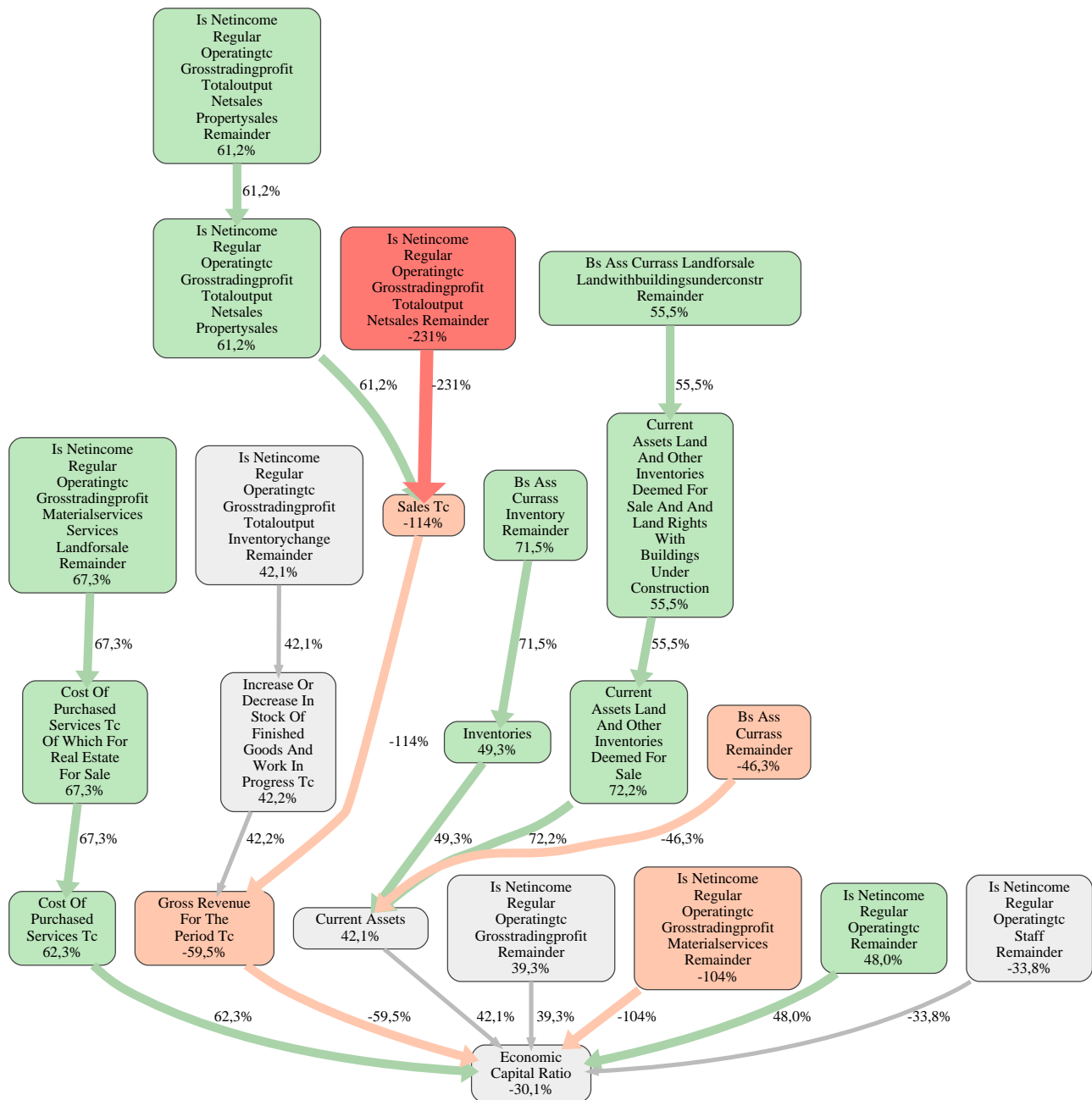

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Current Assets Land And Other Inventories Deemed For Sale, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, reducing the Economic Capital Ratio by 231% points.

The company's Economic Capital Ratio, given in the ranking table, is 73%, being 30% points below the market average of 103%.
