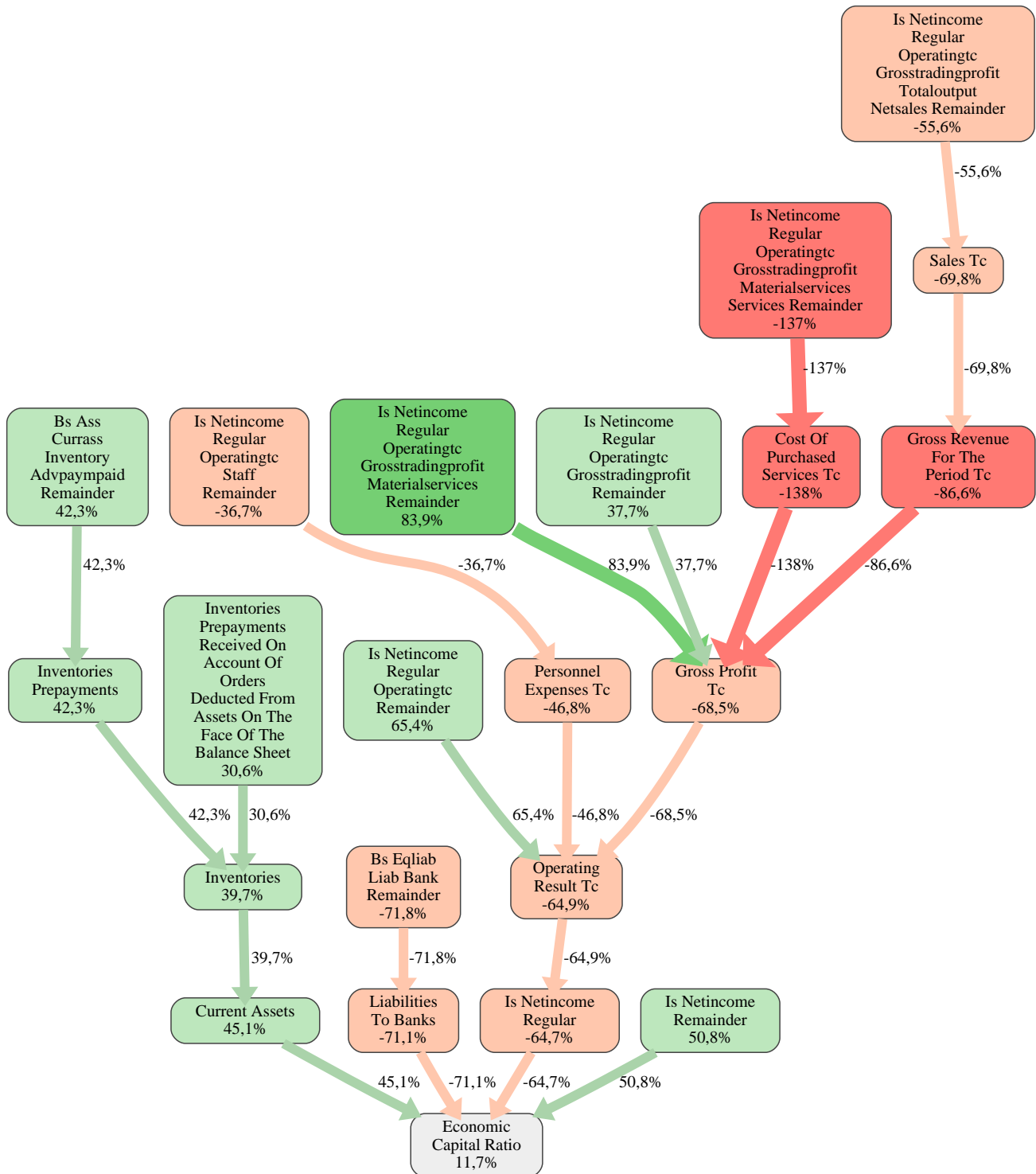

The greatest strength of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of HBB Hanseatische Wohnungsbaugesellschaft mbH Co KG is the variable Cost Of Purchased Services Tc, reducing the Economic Capital Ratio by 138% points.

The company's Economic Capital Ratio, given in the ranking table, is 115%, being 12% points above the market average of 103%.
